OF

PREMIERE HOUSING FOUR LIMITED COMPANY

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act., F.S. 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I. NAME
