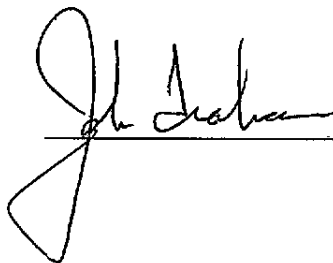
**ARTICLE V

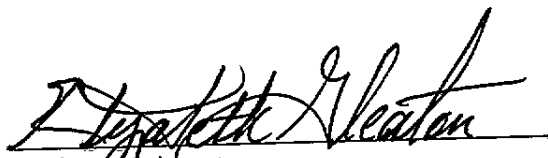
