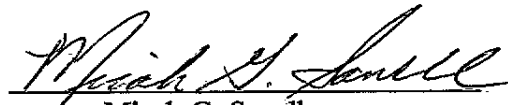
ARTICLE VI - Dissolution and Members Rights to Continue Business
