ARTICLE OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY  
Oasis Multilateral Group, LLC (the "LLC")

Article V - Admission of Additional Members:

Note:        All Identified terms herein shall have such meaning subscribed thereto in that certain Operating Agreement of Oasis Multilateral Group LLC and among each of those Persons executing the same (the "Operating Agreement").

- (a) No assignee or transferee of an Interest, whether a Permitted Transferee or otherwise, and whether the Transfer is voluntary or otherwise, shall be admitted to the LLC as a Member without the prior written consent of a Majority in Interest.
- (b) No Person that is not a Member may contribute capital to the LLC or be admitted to the LLC as a Member without the prior written consent of a Majority in Interest.
- (c) Upon the admission of an additional Member, all references in the Operating Agreement to the Members shall be deemed to include the new Member.
- (d) Except for an additional Member designated as a Manager pursuant to Section 8.9 of the Operating Agreement, no additional Member shall be a Manager.
- (e) Irrespective of whether an additional Member executes any document relating thereto, such Member shall be deemed to have consented to be bound by the terms and conditions of the Operating Agreement upon acceptance of the Interest.
- (f) Unless explicitly set forth in the Operating Agreement, an Assignee shall have no rights under the Operating Agreement other than the right to allocation under Section 6.1 and Section 6.2 and the right to distributions under Section 6.3 and Section 9.4 therein.

ARTICLE OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

Oasis Multilateral Group LLC (the "LLC")

**ARTICLE VI - Members Rights to Continue Business:**

The LLC shall commence as of the execution of that certain Operating Agreement of Oasis Multilateral Group LLC by and among each of those Persons executing the same (the "Operating Agreement") and shall continue until the first to occur of the following events:

- (a) December 31, 2049; or
- (b) The unanimous agreement of all of the Members of the LLC.

So long as the LLC has at least one Member, neither the death, retirement, resignation, expulsion, bankruptcy, dissolution of a Member, or any other event which terminates the continued membership of a Member shall terminate the LLC prior to the above specified events.
