OF

**ARTICLE I**

**Name**

## ARTICLE VII





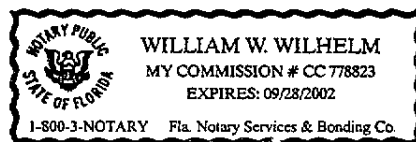
