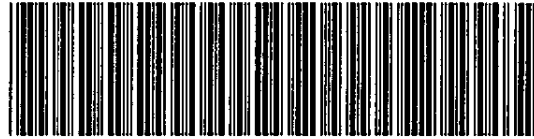

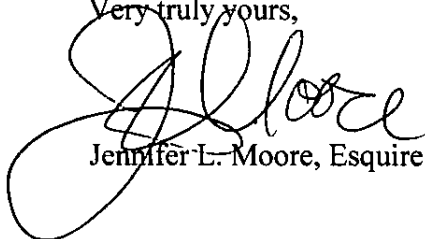

SECOND: The following Amendments to the Articles of Organization were adopted by the Limited Liability Company:

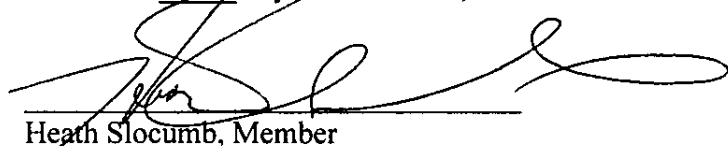
- I. Article III - Management by Members, in its entirety is stricken and is hereby amended to read:

The Limited Liability Company is to be managed by a Manager.

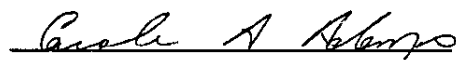
