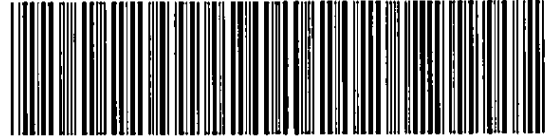

1. Paragraphs 1 through 22 in the Second Amendment to Articles of Organization are hereby deleted.

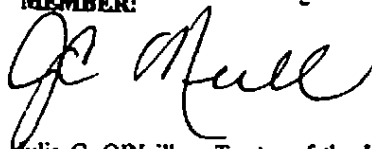

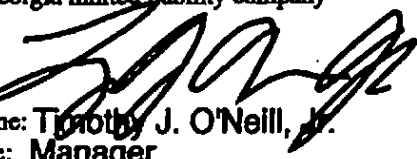
