ARTICLE IX - INDEMNIFICATION

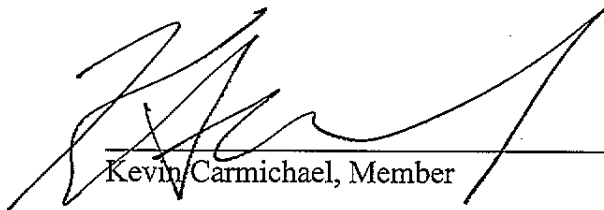
