ARTICLES OF ORGANIZATION

ARTICLE IV

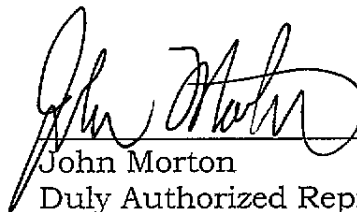
MANAGEMENT
