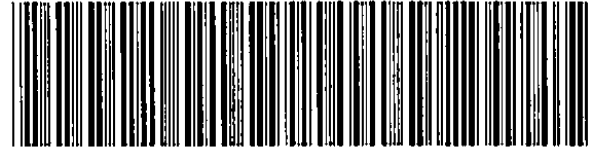

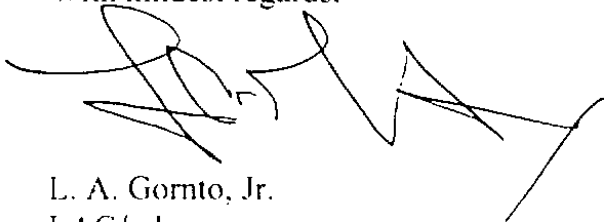

Pursuant to the provisions of Florida Statutes Section 605.0202, The Hooking Family Trust, LC adopts the following articles of amendment and restatement to its articles of organization:

FIRST: Amendments and restatements adopted:

ARTICLES OF ORGANIZATION

ARTICLE 1
NAME

The name of this limited liability company is The Hooking Family Trust, L.L.C.

ARTICLE 2
PERIOD OF DURATION

The period of duration of this limited liability company is perpetual. The date the existence of this limited liability company begins is October 28, 1999.

ARTICLE 3
PURPOSE

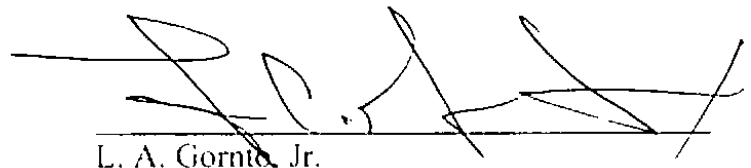

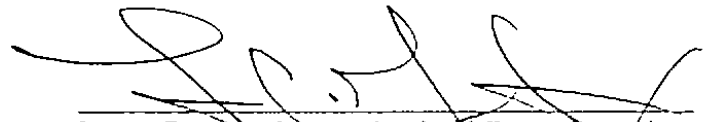
