ARTICLES OF ORGANIZATION FOR WRIGHT DEVELOPMENT, L.L.C.

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned (the "Members") acting as the organizers and the Members of WRIGHT DEVELOPMENT, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, <u>Fla. Stat.</u>, adopt the following Articles of Organization:

ARTICLE I NAME
