**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

WHEREAS, the undersigned Company, by and through its Members and pursuant to the provisions of Section 608.411 of the Florida Statutes, unanimously agreed to amend the aforesaid Articles of Organization in the manner hereinafter set forth;

NOW, THEREFORE, the undersigned hereby amends the Articles as follows:

1. Article "V" is hereby deleted in its entirety, and the following substituted therefor:
"The Company shall be managed by one or more managers as provided in the Company's Operating Agreement."
2. The date of the foregoing amendment's adoption was February 28, 2000.
3. Except as modified herein, the Articles of Organization of said Company shall be and remain in full force and effect.

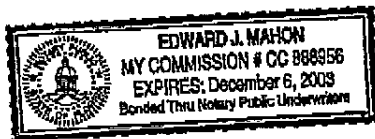
