**ARTICLES OF AMENDMENT TO
THE ARTICLES OF ORGANIZATION
OF REALVEST RESIDENTIAL APPRAISAL, L.L.C.**

Pursuant to the provisions of Section 608.411 of the Florida Statutes, the undersigned Florida company hereby adopts the following Articles of Amendment to its Articles of Organization:

Article I - Name and Date of Filing

The name of the company is REALVEST RESIDENTIAL APPRAISAL, L.L.C. (hereinafter referred to as the "Company"). The Articles of Organization of Company were originally filed on October 25, 1999.

Article II - Adoption and Text of Amendments

The Company has approved a resolution amending Article 1 of the Articles of Organization. The following is a true and correct copy of the resolution amending Article 1 of the Articles of Organization:
