**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a professional limited liability company under the laws of Florida, adopts the following Articles of Organization:

Article I

Name

Section 1.1. Name. The name of the professional limited liability company is:

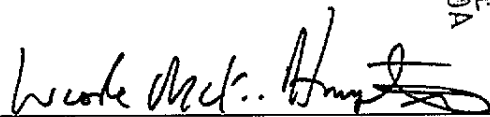
