

ARTICLES OF ORGANIZATION

of

DEBBIE PROPERTY, L.C.

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I
DURATION

Debbie Property, L.C. shall exit perpetually or until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.

ARTICLE II
NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be Debbie Property, L.C., its mailing address Woodhill Lane, Upper Brookville, New York 11545, and principal address 798 South Federal Highway, Suite 100, Boca Raton, Florida 33432, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE III
INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of Debbie Property, L.C. is 798 South Federal Highway, Suite 100, Boca Raton, State of Florida, 33432, and the name of the company's initial registered agent at that address is Ellen R. Itzler.

ARTICLE IV
MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to Debbie Property, L.C.

A member's interest in Debbie Property, L.C. may not be sold or otherwise transferred except with the unanimous consent of the members.

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in Debbie Property, L.C., the remaining members shall have the right to continue the business on unanimous consent of the remaining members.


