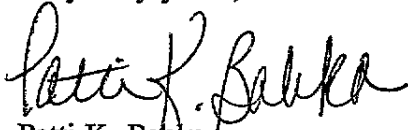

**ARTICLES OF ORGANIZATION OF
DAVID CAMPBELL, LLC**

ARTICLE I

Name

The name of the limited liability company ("Company") is DAVID CAMPBELL, LLC.

ARTICLE II

The mailing and street address of the Company's principal office is 18439 Limestone Road, Jupiter, FL 33458.

ARTICLE III

Duration

The period of duration for the Company is perpetual, beginning on the date that the Articles are filed by the Florida Department of State.

ARTICLE IV

Registered Agent and Office

ARTICLE V

Management

Continuation of Business

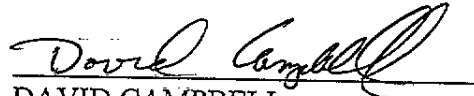

ARTICLE VIII

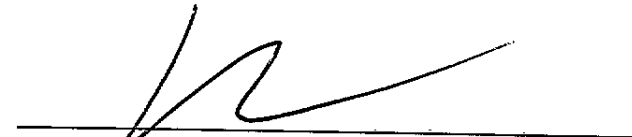
Additional Provisions
