The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be:

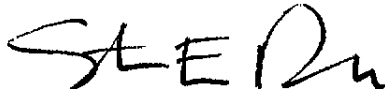
Additional members may be admitted only as unanimously agreed upon by the Members as set forth in the Operating Agreement.

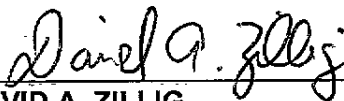
ARTICLE VI - MEMBERS RIGHTS TO CONTINUE BUSINESS

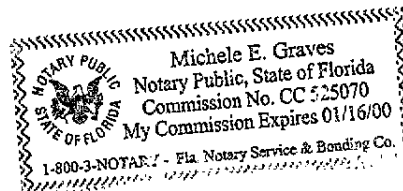

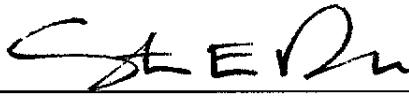
