AMENDED AND RESTATED

ARTICLES OF ORGANIZATION OF MRS ASSOCIATES, LLC

"Limited Liability Company"

The undersigned organizer hereby amends and restates the Articles of Organization of MRS Associates, LLC, pursuant to Fla. Stat. § 605.0202 (2015). Chapter 605, Florida Statutes (2015) shall be referred to herein as the "Act."

MRS Associates, LLC is, and shall continue to be, a manager-managed LLC pursuant to the Operating Agreement of MRS Associates, LLC.
