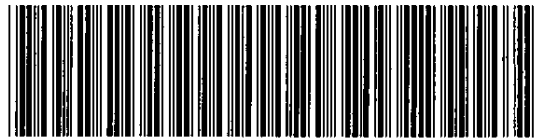

OF

1. The name of the professional limited liability company is Fleit, Kain, Gibbons, Gutman, Bongini & Bianco P.L.
