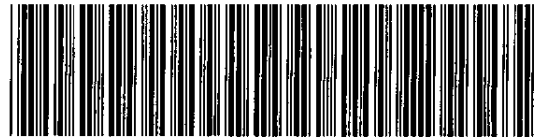

**ARTICLES OF DISSOLUTION  
OF  
FLEIT, KAIN, GIBBONS, GUTMAN, BONGINI & BIANCO P.L.**

Pursuant to the provisions of Section 608.445 of the Florida Limited Liability Company Act, the undersigned Professional Limited Liability Company (the "Company") hereby adopts the following Articles of Dissolution for the purposes of its dissolution:

1. The name of the Company is Fleit, Kain, Gibbons, Gutman, Bongini & Bianco P.L.

2. The Company's Articles of Organization were filed on November 9, 1999 and assigned document number L99000007557.

3. The effective date of the Company's dissolution is April 30, 2008 (the "Effective Date").

4. A description of the occurrence that resulted in the Company's dissolution pursuant to Section 608.441 of the Florida Statutes and the Company's Articles of Organization, as amended, is as follows: The Members holding a majority-in-interest of the Company voted for its dissolution pursuant to a meeting of the Members held on or around Tuesday, March 18, 2008.

5. As of the Effective Date, all debts, obligations and liabilities of the Company will have been paid or discharged (or adequate provision will have been made for the debts, obligations and liabilities pursuant to Section 608.4421 of the Florida Statutes).

6. As of the Effective Date, all remaining property and assets will have been distributed among its Members in accordance with their respective rights and interests.

7. As of the Execution Date, there are no suits pending against the Company in any court. If any suit should become pending subsequent to the Execution Date, then, as of the Effective Date, adequate provision will have been made for the satisfaction of any judgment, order or decree which may be entered against it in any pending suit.

**IN WITNESS WHEREOF**, the undersigned, representing the Members holding a majority-in-interest of the Company, have executed these Articles of Dissolution this 9 day of April, 2008 (the "Execution Date").
