# ARTICLES OF ORGANIZATION OF INDIAN TRADER, LLC

SECRETARY OF SMATE DIVISION OF CORPORATIONS

The undersigned, a member, acting as organizer of a limited liability company under the Florida Limited Liability Act (the "ACT"), does hereby adopt the following Articles Of Organization for such limited liability company:

# ARTICLE I - NAME

The name of the limited liability company is INDIAN TRADER, LLC (the "COMPANY").

# ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

The members of the **COMPANY** are granted the right to admit additional members in accordance with the terms and conditions as set out in the **COMPANY'S** Regulations as adopted and amended from time to time in accordance with the **ACT**.

# ARTICLE VI - MEMBER'S RIGHT TO CONTINUE BUSINESS OF COMPANY

The remaining members of the COMPANY are granted the right to continue the business of the COMPANY on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the COMPANY in accordance with the terms and conditions set out in the COMPANY'S Regulations.

# ARTICLE VII - LIABILITY OF MEMBER FOR DEBTS

Except as and to the extent the COMPANY'S Regulations

specifically provide otherwise, a member shall not be liable for the debts, obligations or liabilities of the COMPANY, including under a Judgment, Decree or Order of the Court. A member shall not be personally liable to the COMPANY or any of the COMPANY'S members for any monetary damages for any act or omission in the member's capacity as a managing member except to the extent otherwise expressly provided by statute of the State of Florida. Any repeal or modification of this Article or the Regulations shall be prospective only and shall not adversely affect any limitation of the personal liability of a member of the COMPANY at the time of the repeal or modification.

# ARTICLE VIII - PREEMPTIVE RIGHTS

Except as expressly provided in the COMPANY'S Regulations, no member, by reason of holding a membership interest in the COMPANY, shall have a preemptive, preferential or other right to acquire any additional or greater membership interest in the COMPANY or any right to subscribe to or acquire any additional or greater membership interest in the COMPANY (or any security of the COMPANY convertible into or carrying such a right).
