ARTICLES OF ORGANIZATION



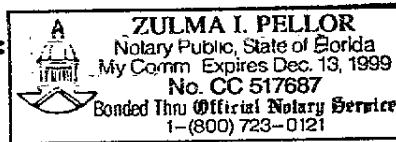
