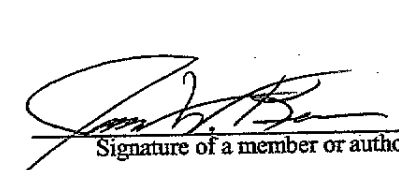
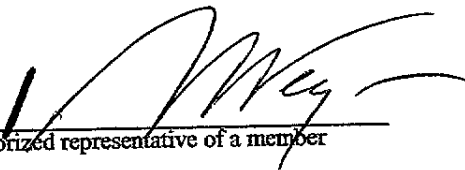
**FIRST:** The date of filing of the articles of organization was November 9, 1999

**SECOND:** The following amendment(s) to the articles of organization was/were adopted by the limited liability company:

The Limited Liability Company is to be managed by one (1) manager, and is therefore a manager-managed company. The manager shall have full power and authority to sign for and on behalf of the Limited Liability Company, and to bind the Limited Liability Company to all legal documents; without limiting and in addition to the general power and authority of the manager as aforesaid, the manager shall have the power and authority to sign and deliver on behalf of the Limited Liability Company (and to bind the Limited Liability Company to) all contracts (including contract of sale and purchase), agreements, deeds of conveyance, affidavits, certificates, mortgages, security agreements, assignments, pledges and encumbrances pertaining to the Limited Liability Company's assets.
