ARTICLE V - Members:

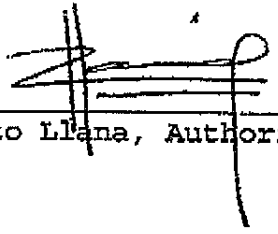
