The mailing address and street address of the principal office of the Limited Liability Company is 4001 Tamiami Trail North, Suite 350, Naples, FL 33940.

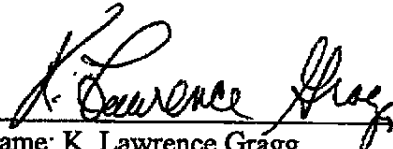
**ARTICLE III - DURATION**

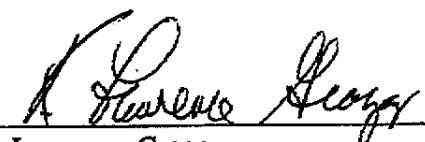
