Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida limited liability company adopts the following articles of amendment to its articles of incorporation:

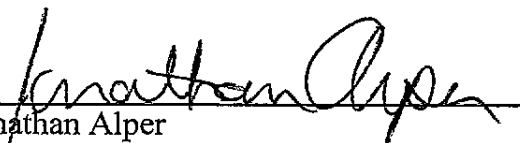
FIRST: Dr. Phillips Restaurant Management Company, L.L.C. was registered on November 12, 1999.
