**ARTICLE THREE**

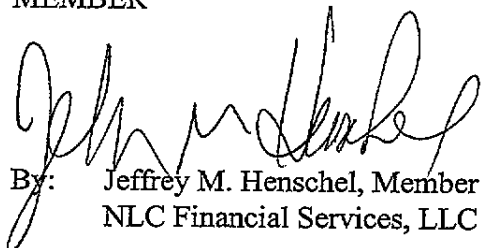
