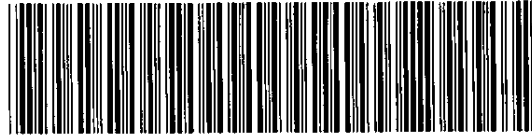

I am the Chapter 7 Bankruptcy Trustee for the above entity, First NLC Financial Services, LLC. I have served as the Trustee since May, 2008. A copy of the bankruptcy notice reflecting the filing and my appointment is attached. I have been on record with your office since November, 2009 as the agent for this LLC (see statement attached).

On April 20, 2015 a Marc H Eugene reinstated this LLC and changed the business address (to a mailbox drop) and made himself the Registered Agent. He did this WITHOUT MY PERMISSION OR KNOWLEDGE!! The reinstatement was fraudulent and needs to IMMEDIATELY BE CHANGED.

I have enclosed my check for \$50 to cover the costs of a) making myself once again the Registered Agent with my mailing address and b) dissolving this LLC so this cannot happen again.

If you need anything additional from me, please contact my office, but I respectfully request that these changes be made and go into effect IMMEDIATELY due to the fraudulent filing by Marc Eugene.
