ARTICLES OF ORGANIZATION OF RITS & Co., LLC

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I — Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "Rits & Co, LLC."

ARTICLE II — Address:

ARTICLE III — Duration:

The period of duration for the Company shall be perpetual.

ARTICLE VI — Members' Rights to Continue Business:

The right, if given, of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company shall be sometimes.

The remaining members of the Company have the right to continue the business upon the occurrences described in the previous paragraph only if so voted by a majority of the interests of the remaining member(s).

ARTICLE VII — Limitation on Agency Authority of Members

Pursuant to Section 608.424 of the Florida Limited Liability Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

Any Regulations (as defined in Section § 608.402(13) of the Act), relating to this Company must be in writing and signed by all of the Members; however, amendments to the Regulations need only be approved by vote of 75% of the members' interests.
