ARTICLES OF ORGANIZATION

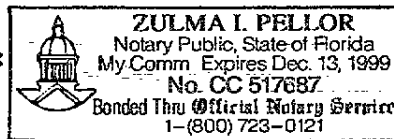




