ARTICLES OF ORGANIZATION

OF

The total amount of cash contribution is \$1,000.00. There may be additional contributions agreed to be made by certain members at a future time.

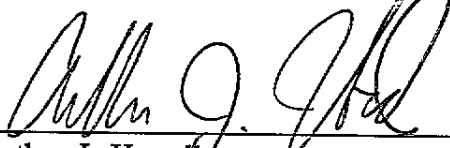
**ARTICLE VIII

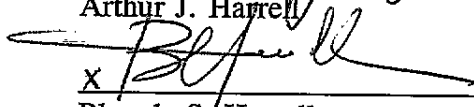
ARTICLE IX
