<u>ARTICLES OF ORGANIZATION OF CATSFIELD, LLC</u>

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

ARTICLE I - Name:

The name of the limited liability company is CATSFIELD, LLC (the "Company").

ARTICLE II - Address:

ARTICLE III - Duration:
