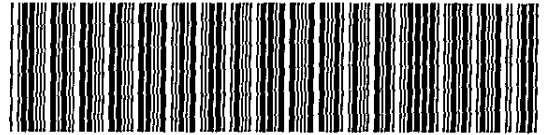

**ARTICLES OF AMENDMENT TO ARTICLES OF
ORGANIZATION OF LAKE MARY BOULEVARD 17-92, L.C.**

The Articles of Organization of Lake Mary Boulevard 17-92, L.C., a Florida limited liability company (the "Company"), are amended as set forth in these Articles of Amendment:

1. The name of the Company is Lake Mary Boulevard 17-92, L.C.
2. The date of filing of the Company's Articles of Organization was November 23, 1999. The name of the Company at that time was Landstar Osceola, L.C. The name of the Company was changed to Lake Mary Boulevard 17-92, L.C. by amendment of the Company's Articles of Organization filed on February 9, 2001.
3. The purpose of these Articles of Amendment is to amend Article 6 of the Articles of Organization of Lake Mary Boulevard 17-92, L.C. formerly known as Landstar Osceola, L.C., to allow the Company to be managed by either members or non-member managers, by providing that the Company will be managed as provided in the Company's operating agreement.
4. Article 6 of the Articles of Organization of the Company is hereby amended to read as follows:

**"ARTICLE 6
MANAGEMENT**

This limited liability company shall be managed by such managers as may be elected or appointed from time to time by the members pursuant to applicable provisions of the operating agreement of the company."

5. This amendment is made pursuant to Sections 608.411, Florida Statutes.
6. This amendment is effective immediately upon being filed with the Florida Department of State.
