OF

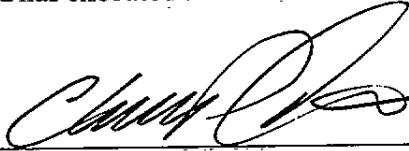

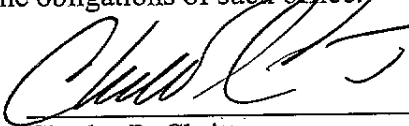
