**ARTICLES OF ORGANIZATION
OF
VAX-D INTERNATIONAL, L.C.**

1. Name. The name of this limited liability company is **VAX-D INTERNATIONAL, L.C.**, a Florida limited liability company (the "Company").
2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles of Organization with the Florida Department of State.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
4. Place of Business. The Company's mailing address is P.O. Box 120, Crystal Beach, Florida 34681. The Company's principal office is 112 Sanctuary Drive, Crystal Beach, Florida 34681.
5. Registered Agent and Office. The name of the initial registered agent of the Company is Joseph W.N. Rugg. The street address of the initial registered agent of the Company is One Tampa City Center, Suite 2200, 201 North Franklin Street, Tampa, Florida 33602.
6. Contributions to the Company; Ownership. The total amount of cash initially contributed to the Company by the members is \$20.00. No additional contributions have been agreed upon. The members own equal interests in the Company, subject to change upon the unanimous consent of the members.
7. Additional Members. Additional members to the Company may be admitted, but only upon the unanimous consent of all members of the Company at the time admission is sought.
8. Termination of Membership. The business of the Company shall continue upon the death, retirement, resignation, expulsion, bankruptcy, termination, or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, unless a majority of the members agree in writing to dissolve the Company.
9. Members; Management of the Company. The management of the Company is reserved to its members. The Company shall be managed by its members in accordance with the regulations and operating agreement adopted by all of the members. The names and addresses of the members are:

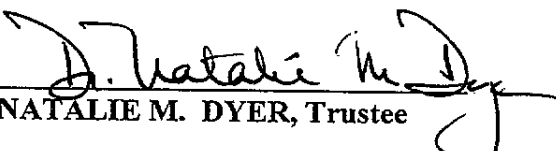
