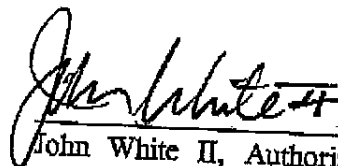
ARTICLE VADMISSION OF ADDITIONAL MEMBERS
