


## **ARTICLE VI - Admission of Additional Members**



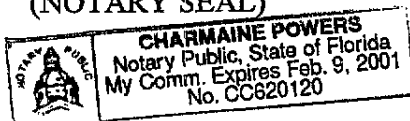
