ARTICLES OF ORGANIZATION

OF

CURRIER ROOF TILE, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Currier Roof Tile, L.L.C. ("Company").

ARTICLE II - ADDRESS

ARTICLE IV - PURPOSES AND POWERS

The members of the limited liability company shall have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the company.




