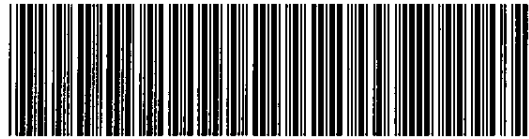



**ARTICLES OF DISSOLUTION  
OF

1. The name of the limited liability company is Precise Weather Capital, L.L.C., a Florida limited liability company (the "Company").

2. The Articles of Organization for the Company were filed on December 1, 1999, and assigned Florida Document No. L99000008326.

3. The date of the dissolution as approved was February 1, 2011.

4. The dissolution of the Company was authorized pursuant to a Written Action in Lieu of a Special Meeting of the Managing Member of the Company dated as of February 1, 2011.

5. Weather Insight LP sold and transferred all or substantially all of its assets to a third party as of February 1, 2011, resulting in the liquidation of Weather Insight LP, and as a result thereof all of the entities, including the Company, holding an interest in and to Weather Insight LP, whether directly or indirectly, no longer have any interest in or to Weather Insight LP and/or its assets, which have been sold, transferred and conveyed to a third party, all of which is in effect provided for in the Operating Agreement for the Company and is consistent with the requirements of Section 608.441, Florida Statutes.

6. All debts, obligations and liabilities of the Company have been paid or discharged.


7. To the extent existing, all remaining property and assets have been distributed among the members of the Company in accordance with their respective rights and interests.

8. There are no suits pending against the Company in any court.

9. These Articles of Dissolution shall be effective upon filing with the Florida Department of State.
