ARTICLES OF ORGANIZATION

OF

MOOG ROAD, LLC

1. **Name.** The name of this limited liability company is **MOOG ROAD, LLC**, a Florida limited liability company (the "Company").

2. **Duration.** The Company shall have perpetual existence from the date of filing of these Articles of Organization with the Florida Department of State until the occurrence of any of the events specified in the Regulations and Operating Agreement for the Company.

3. **Purpose.** The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
