**ARTICLES OF ORGANIZATION OF
THE LOWELL GROUP, L.L.C.
A FLORIDA LIMITED LIABILITY COMPANY**

THE UNDERSIGNED, GREGORY L. ZINK being the sole voting member of THE LOWELL GROUP, L.L.C. ("the Limited Liability Company") pursuant to Florida Statutes 608.407 does hereby execute these Articles of Organization of THE LOWELL GROUP, L.L.C. for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act and does hereby state and set forth:

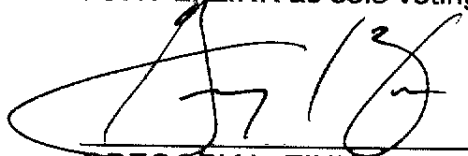
1. The name of the Limited Liability Company is THE LOWELL GROUP, L.L.C.
2. The period of duration of THE LOWELL GROUP, L.L.C. shall be perpetual.
3. The mailing address and street address of the principal office of the Limited Liability Company is 54 River Drive, Ocean Ridge, Florida 33435.
4. The name of the initial registered agent in Florida for the Limited Liability Company is GREGORY L. ZINK and his street address is 54 River Drive, Ocean Ridge, Florida 33435. 5. No members shall be allowed to admit additional members except by a majority vote of the voting members of the Limited Liability Company, or upon such greater vote as may be prescribed by the Limited Liability Company regulations.
6. The Limited Liability Company shall not dissolve and the remaining members of the Limited Liability Company shall continue its business upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company.

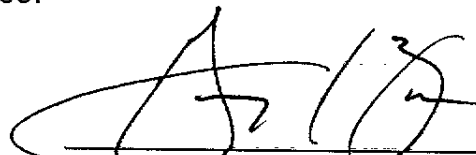
