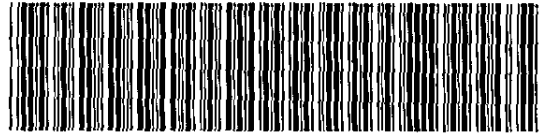

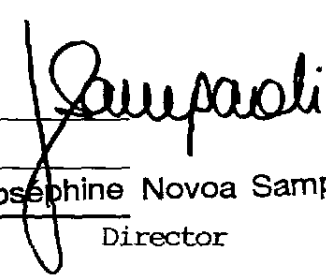
VI. AMENDMENT TO ARTICLES OF ORGANIZATION
