**CERTIFICATE OF AMENDMENT TO ARTICLES OF ORGANIZATION

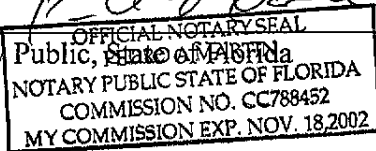

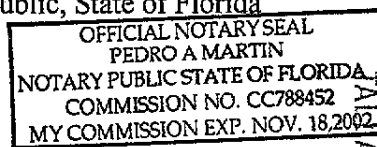
