ARTICLES OF ORGANIZATION

FOR

BT INVESTMENTS, L.L.C.

The undersigned, acting as the organizing Member of Limited Liability Company to be formed under the Florida Limited Liability Company Act, as Amended (the "Act"), hereby forms a Florida Limited Liability Company (the "Company") pursuant to the Act, and hereby sets forth the following Articles of Organization (the "Articles"):

ARTICLE I

Name

The Name of the Company is BT Investments, L.L.C.

ARTICLE II

Commencement Date and Duration

The Company's existence shall commence on the date the Articles are filed with the Florida Department of State, and shall continue for a period of fifty (50) years from the commencement date unless sooner dissolved in accordance with Section 608.441 of the Act.

ARTICLE IV

Principal Office

The mailing address and the street address of the principal office of the Company shall be R. Jay Taylor, 932 5th Avenue West, Palmetto, Florida 34221.

ARTICLE V

Registered Agent and Office

The initial registered agent for the Company shall be G.

Joseph Harrison, and the address of the registered agent for service of process shall be 1206 Manatee Avenue West, Bradenton,

Manatee County, Florida 34205.

ARTICLE VI

Management of Business

The Company is to be managed by a manager or managers. R. Jay Taylor, 932 5th Avenue West, Palmetto, Florida 34221 and William A. Baker, 903 3rd Avenue West, Palmetto, Florida 34221, will serve as the initial managers of the Company until the first annual meeting of the Members or until their successors are elected and qualified. The managers of the Company will be elected annually by the Members. The Members may increase and decrease the number of managers from time to time; provided,

however, there shall never be more than three (3) managers or less than one (1) manager. The managers shall be Members or Affiliates of Members.

ARTICLE VII

Admission of Additional Members

Continuation of Business

ARTICLE IX

Powers

Property

Regulations

Regulations shall be prepared and adopted to govern the internal affairs of the Company containing such provisions as may be necessary, reasonable, or desirable, except that no provision of such Regulations may conflict with the provisions of these Articles unless permitted herein. The power to adopt, alter, amend, or repeal the Regulations shall be set forth in the Regulations.

ARTICLE XIII

Contracting Debts

No debt shall be contracted nor liability incurred by or on behalf of the Company except by its managers, and no Member is authorized or empowered to contract debts or incur liabilities on behalf of the Company unless such Member is also a manager.


