ARTICLES OF ORGANIZATION

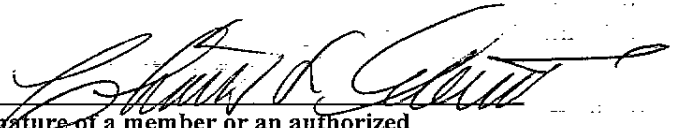
ARTICLE V
