**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION
OF
WELBRO ENTERTAINMENT MAKERS, LLC**

Pursuant to the requirements of Sections 608.411 and 608.4081, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Organization of Wellbro Entertainment Makers, LLC (the "Company"), which Company was incorporated under the laws of the State of Florida on December 7, 1999 under Charter No. L99000008552:

1. The Managing Member of the Company has recommended to the sole member of the Company, the following change to the Articles of Organization, and the sole member of the Company has unanimously voted to change the Company's Articles of Organization.

a. Therefore, the Company's Articles of Organization shall be amended and restated in their entirety to read as follows:

ARTICLE I

Name and Duration

The name of the Company is **ASI WELBRO Construction Services, LLC**. The duration of the Company is perpetual. The effective date upon which this Company shall come into existence shall be the date these Articles are filed by the Secretary of State.

2. All other provisions of the Company's Articles of Organization shall remain in full force and effect and unaltered as expressly provided above.

3. The foregoing amendment to the Articles of Incorporation was unanimously adopted by the Managing Member and the sole member of the Company on the 31st day of July, 2000. The number of votes cast for the name change amendment was sufficient for approval.
