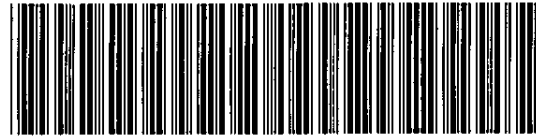

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, provides the following information for the purpose of amending the Articles of Organization of **THE GEMONO GROUP, LLC** (the **Company**).

1. The Company was formed under the laws of the State of Florida pursuant to Articles of Organization originally filed with the Department of State on December 8, 1999, and assigned document number L99000008592. The Articles of Organization were subsequently amended by Articles of Amendment filed with the Department of State on March 13, 2001.
2. Article 1 of the Articles of Organization is amended to read:
 1. **Name.** *The name of this Limited Liability Company shall be **DOMICILE LIFESTYLES, LLC.***
3. Pursuant to Section 608.4231, F.S., and in accordance with the Operating Agreement of the Company, the Members authorized and consented in writing on January 25, 2008, to this Amendment to Articles of Organization. The vote was sufficient for approval.

IN WITNESS WHEREOF, the undersigned has executed these Articles of Amendment to Articles of Organization this 5th day of February, 2008.

THESE ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION HAVE BEEN DULY EXECUTED AND ARE BEING FILED IN ACCORDANCE WITH SECTION 608.411, FLORIDA STATUTES.
