## ARTICLES OF ORGANIZATION OF RIDGE MANOR, LLC

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida statues, does hereby adopt the following Articles of Organization.

## ARTICLE I NAME

The name of the Limited Liability Company shall be Ridge Manor, LLC

# ARTICLE II ADDRESS

The mailing address and the street address of the principal office of the Limited Liability. Company is: 6900 Southpoint Drive North, Suite 250, Jacksonville, Florida 32216.

## ARTICLE III PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

#### ARTICLE IV DURATION

Such Manager shall have the right and responsibilities described in the regulations of the Company. The name and address of the initial Manager is as follows:

Such Manager shall serve in such capacity until the first annual meeting of the Member until their successors are duly elected and qualified.

## ARTICLE VI ADMISSION OF ADDITIONAL MEMBERS

Additional Members may be admitted upon the approval of a majority of the Members of the Company, upon the written application of such new Member, in the manner set forth in the Regulations of the Company.

# ARTICLE VII REGISTERED AGENT AND OFFICE
