**Articles of Organization
of
Hopewell Enterprises, LLC
(A Florida Limited Liability Company)**

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes (the "Act").

1. **NAME.** The name of this limited liability company (the "Company") is Hopewell Enterprises, LLC.

2. **DURATION.** The period of duration of the Company shall be perpetual.

3. **PURPOSE.** The purpose and business of the Company shall be to engage in any lawful act or activity which may be carried on by a limited liability company under the Act.

4. **MAILING ADDRESS AND STREET ADDRESS OF PRINCIPAL OFFICE AND REGISTERED OFFICE.** The mailing address and street address of the principal office and registered office of the Company is: 2905 Satauma Drive, Sarasota, Florida 34239.

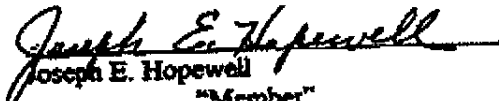

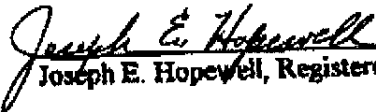
