CERTIFICATE OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Section 608.411 of the Florida Limited Liability Company Act, the undersigned Company adopts the following Certificate of Amendment to its Articles of Organization:

1. The name of the limited liability company is SENECA C, L.L.C. (the "Company").
2. The Articles of Organization were filed on December 16, 1999, and assigned document number L99000008849.
3. The Amendments to the Articles of Organization set forth below were adopted by the Manager and Members of the Company on December 16, 1999.
4. The Company's Articles of Organization are hereby amended as follows:

Article IV of the Company's Articles of Organization is deleted and replaced with new Article IV, as follows:

ARTICLE IV. - MANAGEMENT

The daily, usual course of business of the Company will be managed by its managing member (the "Managing Member"). The Managing Member shall be elected annually by the members in the manner prescribed by and provided for in the Regulations of the Company. The Managing Member shall also hold the office and have responsibilities accorded to him by the members and as set forth in the Regulations of the Company. The members reserve the general management of the Company to themselves, and therefore all decisions outside the usual course of the Company's business will require the consent of a 2/3's majority of the members. 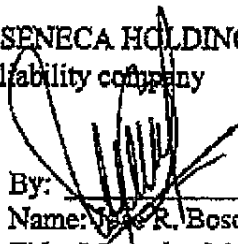
